Our use of collected data

Using our services

Communication

When you send us an e-mail or other message, it is possible that we will store that message. Sometimes we will ask for personal information that is relevant to the situation. We need to do this, so that we can use the information to answer your question and/or answer your requests. The data will be stored on secure servers of Tom's Hütte or that of a third party. We will combine this data with other personal information that we might have.

Purposes

We do not collect or use data for other purposes than the purposes that are in the privacy policies, unless we got your permission beforehand.

Third Parties

The information will not be shared with third parties.

Changes

This privacy declaration is adjusted on the use of this website and the possibilities on the website. Any changes of the website may lead to changes in this privacy declaration. That is why it is advisable to read the privacy declaration regularly.

We offer all guests the opportunity to see, change and delete all personal data that have been provided to us at the moment.
